Board Meeting Schedule

President's Report

Dear 802ARTsHouse members,

I have had the great fortune to lead our organization with our fabulous Board of Directors during our first year of incorporation as an 501c(3) arts entity. It has been a rollercoaster of a year. I will highlight a few of our accomplishments and needs in this report.

Accomplishments:

- As a new Board we centered much time on getting ourselves names and incorporated, with input from you. We also worked hard to research and become a 501c(3) charitable organization. This would not have been possible had we taken on the reins of Vermont Hand Crafters. Switching business designations would have been difficult and even more time consuming. We decided on a fresh start with a new name. We incorporated officially on October 25, 2023 and we received our 501c(3) designation on November 14, 2023.
- November, 2023 Craft Vermont Show (last VHC show) became our launching vehicle to talk with past members about the opportunities ahead for our new organization. At this time, we had also been working with Charley Dooley of StarBird Events in regard to the 2024 show at the DoubleTree Hilton. BOTH StarBird Events and the 802ARTsHouse Board realized that by collaborating together, we could create a vibrant new show. We worked hard to let the public know that while the previous organization was not producing the next show, we were, as a group of artists, committed to making sure the new show ran with our members in it. Charley agreed to fill the show Exhibition Hall with 802ARTsHouse members only and to brand it as such. Our goal of getting name recognition had begun!
- By December your Board was developing new programs, created bylaws, and an online jury process. The jury process was active and we were bringing in new artists to the organization. We also surveyed our new members and were reaching out to past members and more across the state. We saw our membership numbers growing each month. We put together two smaller shows at Smiley Manse in Springfield for May and at RiverLedge Farm in Grafton for August. Neither show ran, but we did generate interest from our members. The Board was (and is) trying to address having shows in the southern portion of the state. The Board also voted to increase our Vermont Region by including the contiguous states of New Hampshire, Massachusetts, New York, and Quebec. 802ARTsHouse has several new members in these areas.
- Under the leadership of Alyson Chase, our affiliate program was developed and we brought on several affiliate galleries. They are:
 - The Smiley Manse, Springfield
 - Artist in Residence, St. Albans



- Northeast Kingdom Artisans Guild
- Milton Artists' Guild
- Frog Hollow Gallery
- Artisans Gallery, Waitsfield

- In June, our organization was approached by Tim Ciancola of Craftproducers. Tim asked if our group might collaborate with him about the Southern Vermont Art & Craft Festival in August. The Board agreed and we began promoting the show. In return, Time offered us free booths for artists who had experienced damages in the July floods. He also gave us a 20x20' tent to use at the show at no cost to 802ARTsHouse. We worked the gate and also helped with parking. All workers were paid by Tim. At this event, we set up our first 802ARTsHouse gallery, showcasing and selling multiple members' arts at the show. We talked with customers and artists alike, letting them know who we are and what we hope to do. Our FOUNDATIONal Campaign was started right before this show and we solicited art pieces from members to fill two raffle baskets. We sold tickets and accepted donations at this show and will do the same at the Celebrate Vermont Festival.

Also in June, we launched our *Celebrate Vermont...A Bird's Eye View* program with affiliate galleries. This has been a great success! More information is later in this report.

- Our website is chock full of our work and we have created a presence on social media with our Instagram account followers growing daily! Monthly ART CHAT newsletters have been emailed to 802ARTsHouse members and our entire mailing list. Many, many (too many) emails have been sent to members in regard to our programs, the work of the Board, and more. Our Board is committed to maintaining an open communication channel!
- In working with StarBird Events, we are already thinking about next year's November show! Our two organizations have benefitted from our collaborations. StarBird Events has planned with us a brand new tented show in Quechee for next September 26-29, 2025. We are excited to see what is next!

This is only a sampling of what the 802ARTsHouse Board has been up to this year. We are energized by you all. Your support has been invaluable. It is only up from here!

Jury Chair Report

2024 Jury Report, November 1, 2024

The Jury process starts when an interested artist visits the 802 Arts House website and selects the Jury Application page. Once the application is filled in and completed it is added to the Jury Application Google form. This form is checked daily for any new additions. The application is checked for valid information and I also ensure that I have received at least 8 to 10 pictures of the artist's work in my email.

I will then single out at least 4 or 5 current members of 802 Arts to review the application and the pictures of the work. I try to select jurors who have been in 802 Arts for a longer



period of time, especially those who have been past members of Vermont Hand Crafters. I send these prospective jurors the application, all the pictures and a Google evaluation form for their input. If at least 3 of the jurors return their evaluations in the affirmative I will send the artist a congratulatory email which contains the link to join 802 Arts. Once they join, Ellen then sends them the link for the November Art, Craft, Sip and Taste Show. Their email address is also added to the list of members who receive monthly/weekly mailings from the board.

If the evaluation forms come back with less than favorable reviews I send the info to other jurors for their review, trying to get a positive consensus opinion of the work. I have on occasion picked up artwork so that jurors could examine the work first hand. This usually results in a positive review. I have on occasion gotten back to the prospective member with some of the comments from the jury however it is thought that this practice should be done at a minimum.

Since the inception of 802 Arts House we have had the following results from the Jury Process.

- 70 Jury Applications Submitted
 - One from a VHC member who did not need to submit an application she was immediately admitted
 - Two from a "joint" applicant that should have submitted only one application
- 68 Valid Applications
 - 56 Applications approved and applicant joined 802 Arts House
 - 5 Applications were approved and applicant has not taken the last step to join
 - 2 Applications where applicant was repeatedly asked to send pictures and has not done so
 - 1 Application where applicant was asked clarification questions and they did not follow through
 - 1 Applicant when asked to send more pictures and information decided to not finish the application
 - 3 Applications still in process
- The 56 approved applications by media type
 - 8 Fiber Knits, Weaving, Surface Design, Clothing, Felt Sculpture
 - 3 Glass Fused, Stained
 - 3 Wearable Art
 - 11 Framed Art Pastels, Watercolors, Acrylics, Oils, Printmaking, Posters
 - 6 Wood Turning, Cutting Boards, Scroll Saw Work, Carving, Furniture

802ArtsHouse is a community of artists cultivating a high level of artistry and creativity through collaboration, promotion and advocacy for the arts.

Our work began when 30+ current members of Vermont Hand Crafters (VHC) gathered together to chart a new future for the group. Vermont Hand Crafters retired after over 70 years as a leading Vermont arts organization. Many of the original artists of VHC developed this new arts entity with a 501(c)3 designation as a charitable organization to support the arts and artists. We are excited and energized to support artists in our Vermont Region. Members are juried into **802ARTsHouse**, and as such they reap the benefits! Watch for 802ARTs shows, affiliate offerings, classes, workshops and more. We are just getting started!

Six members of the original group volunteered to be the founding board members for this new corporation. They are:

Gary Walz Zoie Parent Alyson Chase Dee Christie Jim Holzschuh Ellen A Thompson

Currently this group is working on several avenues at once. We set up the corporation, **802 ARTs House, Inc.**. We created bylaws, determined Board member roles and set up a website at https://802artshouse.org. We have populated the website, developed a new jury procedure, set the membership cost and benefits as well as set board goals for this first year. Our application to become a nonprofit charitable 501(c)3 corporation after our official incorporation meeting has been accepted. We are more than excited. This IS happening!

We have the members... 157 as of today. We have the ideas and we have the energy. What we do not have is the MONEY to produce a BIG show. Our members deserve a show that will make their artwork sparkle, a show that brings in multitudes of shoppers looking for that unique handmade gift made in the Vermont Arts Region. Large shows situated in hotel conference centers require huge upfront payments to lock in the event.

Historically, most of our current members who were Vermont Hand Crafters had such a show held in the Burlington area for over 70 years on the weekend before Thanksgiving. This show had location, name and date recognition, and the assurance that the arts and crafts presented were the very best.

802ARTsHouse is growing its artist group and is expanding our Vermont Arts region to include all states contiguous with Vermont. We have created affiliations with many Vermont galleries and shops. Through the use of social media and collaborations with other arts organizations we are gaining our name recognition. We are proving our mettle to the Vermont arts world!

Before we can sign on to produce a large arts show, we need to have the money needed in reserve to contract with a location. This **802ARTsHouse FOUNDATIONal Campaign** will allow us to create the balance needed to support a show.
